High Demand for lots at Peel's Retreat

The developers of Peel's Retreat, a boutique land development of 147 lots near the Peel Estuary off the Old Coast Road Mandurah, has rushed lots onto the market in response to high demand for larger sized lots in a superior location.

A pre-release of 11 select lots out of a total of 19 lots making up Stage 2B of Peel's Retreat are sized between 702 – 1057 square metres and are priced from \$175,000 to \$205,000.

All lots are fully serviced and ready to be built upon with natural gas, wide frontages and high-speed internet services.

The previous release of Stage 2A in July 2014 were 26 lots of similar size and value and only 6 remain.

Peel's Retreat is nestled in a natural bush land setting, with Peel Inlet to the east and the Indian Ocean to the west. The Mandurah CBD is minutes away, and the Estuary is 300 meters away via pedestrian access.

Two primary schools and a boat ramp are just around the corner, as well as a newly constructed shopping centre in Dawesville.

Developer and selling Agent Brian Newman from Heath Development Company noted that 'this stage was not scheduled to be released until early 2015, however to keep up with the recent buyer demand, we decided to release the lots early'.

'It is ideal opportunity for buyers to secure their lot for summer for the right price'.

Peel's Retreat is a joint venture project between Perth based developers Heath Development Company, Markham Development Group and Estates Development Company.
